Preamble

Rohan Braddy, chief executive officer and **company secretary**, commenced proceedings at 6.32 pm.

Customer presentation

A number of scrapbooks created by participants from Deer Park hub and facilitated by Caroline McMillan was on display prior to the commencement of the AGM.

Acknowledgement of country

The company secretary acknowledged the Traditional Owners of the country and paid respect to their Elders past, present and emerging.

Official AGM

The **chair**, Paul Larcher, officially opened the 2022 annual general meeting at 6.35 pm and welcomed those in attendance.

1 Attendance

The chair advised that the other directors in attendance at the meeting were Chris Cullin, Emanuel Tumino, James Barrie, Jennifer Webster, Kevin Glennon, Les Chitts and Marija Maher.

Guests attending the meeting included Ryan Leemon, our auditor from Moore Australia, and Sarah Fordyce, the Victorian State Manager at National Disability Services.

2 Proxy holders

Paul advised that there was one proxy form received, but as there were no matters on the agenda requiring a vote of members, proxies would not be needed.

3 Apologies

We received 23 apologies, officially recorded at the beginning of these minutes.

4 Ordinary business

4.1 Minutes of the previous AGM

The minutes of the annual general meeting of the company held on 29 November 2021 were received and considered. No amendments were proposed.

4.2 Report on behalf of the board

The chair presented the board report for the financial year ended 30 June 2022 which was received and considered by the members.

4.3 Financial report

The company secretary presented the financial report and auditor's report for the financial year ended 30 June 2022 regarding the transactions of Mambourin which were received and considered by the members.

4.4 Auditor's report

The independent auditor's report notes the auditor's opinion that our financial report was prepared in accordance with the relevant Australian Charities and Not-for-profits Commission Act, giving a true and fair view of our financial position and performance for the year ended 30 June 2022 and complied with the relevant Australian Accounting Standards.

One question was received prior to the AGM regarding fees that are paid to Mambourin by NDIS participants for services showing as GRANTS in the financial statements, and whether they should be identified as sale of services.

The use of the term "grants" has been our longstanding practice. It is being used to distinguish from other sources of income in particular our commercial income in Mambourin Business Services and is being used as a proxy for "government funding" (it isn't all NDIS fees, although that would be the majority).

Use of the term Grant is in accordance with our accounting policy:

Grants

Grants are recognised at their fair value where there is a reasonable assurance that the grant will be received, and all attached enforceable performance obligations will be complied with.

This is the view of the auditors.

We will look at changing the use of this term in future reports and will probably use the term "Funding" which is the term we use in our internal monthly reports. We could further break that down into NDIS fees, etc in the Notes to the Accounts, subject to auditor's advice.

CEO report

Recognition of years of service and attendance

The company secretary noted that for many years Mambourin has congratulated and acknowledged people who have been part of our organisation over the years, especially those showing long-standing loyalty and connection.

The list of names is at Appendix 1 of these minutes.

Tributes

The company secretary acknowledged those members of our community who died during the year and extended condolences to family and friends.

These tributes are at Appendix 2 of these minutes.

4.5 Declare the result of the election of directors

The company secretary provided some background information, noting that Mambourin's board consists of up to nine elected directors and up to three appointed directors on a rotating cycle.

There were four vacancies for elected director positions at this AGM.

Two directors' terms conclude at this AGM: Paul Larcher and Emanuel Tumino. Emanuel reached the maximum of nine years. A special thanks was extended to Emanuel for his tremendous dedication and diligence.

Paul Larcher nominated for a further three-year term with the full support of the board, and there were three other director nominations from members Mario Briffa, David Cullen and Caroline Pilot.

The number of nominations received did not exceed the number of vacancies, therefore a ballot was not required, and all four directors were declared duly elected in accordance with S10.3.3 of our constitution.

Of the four positions available, three are three-year terms; and one position is a two-year term.

A ballot will be conducted to determine the elected director who will take up the two-year term and the other three directors will be placed into a three-year term.

The company secretary extended thanks to all directors for volunteering their time and expertise.

5 Special business

There were no items of special business.

Meeting close

The chair thanked all directors for volunteering their time and expertise and also extended thanks to staff members for their ongoing dedication to Mambourin.

The annual general meeting concluded 7.28 pm.
